EC- PIEs: - Empowerment for better livelihoods, including skills development and vocational education and training, for marginalized and vulnerable persons and people dependent on the informal economy

This will be achieved through the three integrated strands of the action's intervention strategy. The first strand will increase awareness of socio-economic rights and entitlements to decent work and mobilize people dependent on the informal economy to claim those rights; the second will enable young men and women to gain life skills and vocational skills, improve their access to decent work opportunities and increase incomes. The third strand is aimed at developing an understanding of the context, the history and practice of policies related to people working in the informal sector both within India and internationally in order to better frame, analyze, monitor and implement them.

EC- EIDHR: - Securing the rights of minorities and people affected by caste-based discrimination in India

To enhance access to justice and basic services for minorities and people affected by caste-based discrimination in four states of India through advocacy, capacity building and community-led monitoring of laws and policies.

Disadvantaged population groups in Bihar have knowledge of and access to government programs and their rights to contribute to a just and peaceful society where natural resources are used and good governance is practiced

Community Based organizations have been formed and organized in different nature such as issue based groups, youth and women groups. These groups will be capacitated through regular awareness programmers', orientation, capacity and skill building programmers' and trainings. Community leaders from the reference community mentioned above will be supported and promoted to strengthen civil society actions in the state. The target community has access to resources to secure their livelihood. Community organizations carry out collective actions to implement local government programs.

CARITAS INDIA:- Enhanced Food and Nutrition Security of Musahar Communities by strengthening household level food and nutrition sufficiency and functionalizing Public Health and Nutrition Systems.

The program therefore will relate to four main concerns viz (i) Strengthening/Creating household-level food production and livelihood systems, (ii) Increasing representation in local governance and good governance systems (iii) Functionalizing Public Systems and (v) Improved standards of Water and Sanitation and Hygiene. As per the strategy (given above as a diagram), malnutrition and hunger will be addressed with a multi-pronged strategy which will seek to create household-level food sufficiency and creating participatory governance which in turn will ensure public systems function well.

Program Performed

EC- PIES:- Securing rights and sustainable livelihoods through collective action and education for people dependent on the informal economy in India.

Executive summary of the Action

The project is Empowerment for better livelihoods, including skills development and vocational education and training, for marginalized and vulnerable persons and people dependent on the informal economy. Supported by European Commission and ActionAid Association has been implemented by Prayas Gramin Vikas Samiti (PGVS), Patna. The PGVS are working this project areas in the 30 villages of the Amas Block in Gaya District of Bihar on Agriculture Labour, Sharecroppers, and Marginal Farmer and they are mostly belongs to Dalit Community. The distance of Amas block to District Gaya is approx 70 KM and State Capital is approx 180 KM. from Amas. The PGVS working with total 24021 populations, (13486 male and 10535 female) in Dalit Community in Amas, Gaya.

Activities perform

- ➤ Meetings with PIEs to Collectivize them: -The PGVS organized 14 Meetings of two days of DAM at Block level Committees where 753 people participated in whole (343 women and 410 male); at project office Amas Gaya which included Marginal Farmers, Sharecroppers and Agricultural Labours, and there were also discussion on Socials Security Scheme, PDS system and MGNREGA with Agriculture department Government Officials and PRI members. Mr. Manoranjan ji, Assistant Technical Manager (ATMA) discussed about Agriculture schemes (Agriculture Department Provide crops, seeds, subsidy, vermin compost, technical training etc for Agriculture) process of registration in ATMA and the required documents to take benefits from these schemes. The Agriculture Department Committed for registration of 9 villages and group and subsidy too which is truthful.
- Registration of PIEs with welfare boards and other Government constituted bodies:- Community are getting aware with important registrations under welfare boards and Govt. constituted bodies for accessing the benefits of socio-economic rights; The migrant labourers, their relatives and other villages understood about the benefits of the labour rights.
- Establishment of Workers' Facilitation Centre:- Workers Facilitation Centre were established at 6 Panchayat level, at Jhari Panchayat, ShawKala Panchayat, Barkichilmi Panchayat, Rampur Panchayat, Karamdih Panchayat and Amas Panchayat of Amas Block; Information Materials and Application Forms are available at the Workers Facilitation Centres related with various Govt. Schemes; 2 days in a week the Workers Facilitation Centres open at 9:00 am to 12:00 pm for information to the community members about the Govt. Schemes and also apply application here for process of accessing the benefits during this time or period.
- Awareness campaign and trainings on social security benefits, provisions, schemes and labour laws for the PIEs through cultural activities and other modes:- The PGVS team organised 6 units of Awareness program, in which around 6000 people participated in it. Awareness was done on different issues of sharecroppers and agriculture related schemes and social security schemes. Issues of migrant workers, construction workers, child labour and thei related schemes were

- also addressed in the campaign. Resource centre related information and how to access their help were taught to people.
- ➤ Training on Existing Labour Provisions and social security schemes for the PIEs:- The PGVS 8 unit Training Workshops of two days were organized on Existing labour provisions and Social Security. Total 393 persons (183 female and 210 male). The major focus was on Social Security schemes and Construction Workers Welfare Scheme provisions and Legal Rights, Minimum Wages, Inter-State Migrant Workers Act, Leadership role and responsibility for Committee and VDP. Process of Committee registration under union council and what to do with it and work for labour right. Training on Labour Registration was given which was started in Bihar especially for construction worker involved in building construction and related work. In this scheme provisions have changed and more benefit for their family were included. They also told about informal labour and agriculture labour and their scheme. The said Trainings were facilitated by Mr Gajnafar Nawab (General Secretary AITUC)
- ➤ Leadership Training of Women:- The PGVS organized 6 Training Workshops of two days for Women Leadership training of DAM members. Total 245 people participated of which 30 male and 215 were female; This training was 2 unit but we merged of this training in one unit; The major focus of the Training was on women empowerment, women violence and women workers issues, Women Rights, identify and sort out their social, economic and political issues; Citizen Rights & Legal Provisions for Women, domestic violence Act and protection Act, role of women leadership in village development plan and their Roles in strengthening CBOs; government Scheme for women and process of accessing their right also tell about where they apply related issues; The said Training Programme was facilitated by Mrs. Priti Bariar (secretary of Swarth)
- ➤ IEC Material Develop brochures, handbooks, manuals and toolkits for activists and other campaigners informing them of core policy issues:- The PGVS printed booklet of IEC materials for information and scheme related to informal sector labour and scheme, Agriculture based scheme. In this year we printed information and process of pulses, wheat, rice, vegetable and mushroom farming in technically way. We had also used and distribute during awareness programme of previous materials and some has on resource centre; Migrant labour scheme; construction labour schemes; child labour schemes; Structural outlays of core committees and how to access schemes and benefits. The PGVS also printed Scheme related forms (old age, widow, disability, MGNREGA, labour registration and cast, residential, income, forms) available on resource centre and office;
- ➤ Social Audit and Public Hearing:- Total 2 units of social audit and public hearing were done in which around 400 people participated, PIEs Participant and Amas BDO, PRI members. In the 1st audit Rupesh kumar along with the other participants of 2nd trip were included as juri members. 2nd trip Judi members were- Actionaid P O (Pankaj Shwtabh), PGVS president (Kapileshwar Ram), Gaznafar Nawab, Vijaykant and Prem Prakash were participant in Judi member in Jhari panchayat of Amas for 5 villages on Indira Awas Yojna scheme; The Result Come out that in Indira Awas Yojna Scheme has corruption; agent or vikas mitra has taken 2000 to 10000 for indira awas assessed in 5 villages. If person try them self then the government officials ignore and pending their work due to some resons. Late instalment payment, lack of

- knowledge of their BPL List and Vikas Mitra not share regarding information. Name cutting of eligible persons and add of ineligible persons on demand in BPL list
- Exposure Visit:- One time visit, Total 57 people went for the exposure visit of which 28 male and 29 female were the participants. They went to Pavapuri, Nalanda at NBSKPK to learn livelihood skill on home based enterprises, and group/collective farming.
- ➤ Life Skills, personal development and enterprise building workshops and trainings conducted for the PIEs: 2 training camps were organized for the life skill trainings and personal development of the PIEs and other villagers in the project area. In total 73 persons received training on life skills which included 27 males and 46 females.
- ➤ Vocational trainings held for the PIEs: 6 training units were organised. 349 persons (116 male and 233 female) registered with ATMA of Agriculture Department. 5 male persons got training on goat rearing from ATMA (BAMETI, PATNA) for 5 days. 26 female persons got training on Mushroom cultivation from ATMA at Dhibra village DAM group for 5 to 6 days. 6 female persons got training on Animal Husbandry and Milk products from Animal Husbandry Department for 6 days. Black Grain Seeds distributed in Baghmarwa- 4 KG, Budhaul- 4 KG, Malarwadih- 4 KG, Imaliyatad- 2 KG, Sukradih- 2 KG for cropping from Agriculture Dept. (ATMA) which is free of cost. Groundnut seeds distributed in Baghmarwa- 30 KG for cropping from ATMA which is subsidy scheme. 10 day Training on agarbatti making to 20 females were provided.
- Facilitation of self-employment / supporting trained PIEs / facilitation for formation of cooperatives: 1 unit of programme was done in which 27 people attended it. 20 male and 7 female participated in it. Agriculture and animal husbandry related knowledge sharing was done.

EC-EIDHR:-

Securing the rights of minorities and people affected by caste-based discrimination in four states of India

Executive summary of the Action

The action aligns with one of the main objectives of EIDHR on protection of human dignity and fighting discrimination in all its forms. The action strengthens the capacities of Dalits, DNTs and Muslims (including the most backward Muslims), and especially women amongst these groups in accessing justice, and basic public services. This project Supported by European Commission and Action Aid Association has been implemented by Prayas Gramin Vikas Samiti (PGVS), Patna. The PGVS are working these project areas in the 50 villages in Patna and Vaishali and overall Bihar we work for Fact finding missions, Monitoring of atrocity cases and Victim support for rehabilitation.

Activities perform

➤ Quarterly Project Review meeting: - The project review meetings were organized at PGVS Office. We briefly discussed on project activity plan, problems faced by HRDs in fact finding, reporting format, compilation of documents and files, victim support, social security schemes, and budget. The task assigned to the HRDs and all concerned person to focus more on the monitoring of the cases.

- ➤ Leadership Training for HRDs:- The training briefly the issues of Scheduled caste, Different legal provisions, leadership qualities of HRDs. Common mistakes in filling FIRs and other applications. POCSO Act, Women' property rights. HRDs are demonstrated how to track cases pending with the court, to know the status etc.
- Fact finding missions on crimes against Dalits, Muslims and DNTs:- Fact Finding has been done 30 cases. For different cases Teams are now following the cases and doing advocacy with the concerned departments in the Bihar.
- ➤ Monitoring of atrocity cases: In this year 15 case had monitoring, this action works with sc/st ,DNT and minorities and ensures access to justice through providing legal support to victims, advocacy with the relevant authorities backed by monitoring of atrocities and crimes. It also ensures their access to basic services of employment, food security, social security, education and health care. These objectives are achieved through community led monitoring of implementation of laws, policies, schemes and services, capacity building of the discriminated minority groups and advocacy with the relevant authorities.
- Facilitating access to schemes for the communities:- In this year 14 awareness programs were organized in project area Patna and Vaishali and as well as in others district (Gaya, Jehanabad, Nawada, Nalanda, Aurangabad, Buxar, Saharsa and Rohtas) on land right and SCSP act. Implementation through signature campaigning with community members. Participants understood about Social Security Schemes and Rights to Public Service Acts, 15 points programs.
- ➤ Victim support for rehabilitation:- Under the EIDHR project, 11 families were supported to their livelihood in Madhubani khutauna, such as Thela rickshaw, hand Thela, Grocery shop, cosmetic shop.
- ➤ **IEC** material and knowledge products: The PGVS published books on government scheme and land rights. A total no of books 1250 will be distributed among the community members for knowledge buildup.

EU Swadhikar: - Capacitation of Dalit, Adivasi and Women CSOs for Sustainable Development and Promotion of Diversity and Social Inclusion in India.

Executive summary of the Action

The project is Capacitation of Dalit, Adivasi and Women CSOs for Sustainable Development and Promotion of Diversity and Social Inclusion in India, for higher education and economical development. Supported by European Union and NCDHR has been implemented by Prayas Gramin Vikas Samiti (PGVS), Patna. The PGVS are working these project areas in the 28 District in the Bihar.

Activities perform

➤ Evidence based advocacy at state levels:- In this year One day Meeting was organized by PGVS Evidence based advocacy at state levels. This program was organized in the BIA hall of Patna under the banner of the PGVS .In this Program 7

alliance network partners organized Interface meeting with government officials on the issues of informal sector workers them discus of Social Security and Minimum Wage Policies for unorganized sector Workers. All the alliance members have struggling to get attention of the Govt. for making of effective policies for ensuring rights and justice to the Informal Workers which is still in vein. Hence, there is pertinence to discuss over the issues of unorganized workers right, bring solidarity among us and process social actions for policy advocacy with the Government.

- ➤ State level capacity building workshops with wider network of CSOs and CLOs:In this year three-day workshop was organized by PGVS for State level capacity building workshops with wider network of CSOs and CLO. This program was organized in the Thakur Prasad Community Hall of Patna under the banner of the PGVS. In this workshop, the director and assistant, non-governmental institute of 28 districts working in Bihar State, field workers and students. Over all we discussed in the three days that we will have to be implemented of SCSP/TSP budget, Higher Education and horticulture through the advocacy with related officer and department.
- ➤ **IEC materials Develop:-** The PGVS published books on SCP TSP, specific schemes, information on budget allocation and means of utilization, ways to access budgetary entitlements and schemes for wider dissemination in vernacular languages A total of 2000 books will be distributed among the community members.
- ➤ State report cards in local languages: The PGVS published report card on the status of implementation and access to higher education, entrepreneurship and livelihood (horticulture) for SC/ST youth with recommendations there of A total of 5000 Report card will be distributed among the community members.
- ➤ State level engagement & advocacy: In this year PGVS organized meeting with 5 Universities in Bihar for mechanisms to expand the access to resources and facilities for higher education.

Case Study

1. Case Study on Kishori Samiti and Malnutrition Village- Murli Bharna ward No.-8 Sada Tola

Introduction- Babita Kumari, Age- 10 years, Mothre's Name- Sanju Kumari, No of Family Members.- 7 Village- Murli Bharna ward No.-8, Panchayat- Murli Vasantpur, Block- Kahra, PO- Vangawn, Dist.- Saharsa is Project Area. Total 34 houses hold Population of this village under suposhan project for free malnutrition affected. Project Area Details- the Area situated is east side canal, west side sundarvan, north side Mahidagra and north side bada.

History- in this village has lack of education, cleanliness, land for living, all are landless especially Babita Kumari's Parents have also not received Land Pacha till date. Their parents are agriculture labour and worked in another Farm for their family livelihood. 90% Male persons migrant for livelihood from this village. Male and Female work together then arrange their Pabulum otherwise they will not work one day then they survive for fasting. This girl was ill and under treatment so the PGVS team work on them under Suposhan Project with the help of Caritas India since Feb. 2018 in this village. In this village has formed C.B.O. and 3 Committee like Mother Committee, Adolescent Committee and Community Development Committee after we discuss on malnutrition through committee also we discuss on Health & Hygiene, Nutrition and cleanliness. Babita's family also present in the meeting and the PGVS support to their treatment in the Hospital after checkup find TV and Doctor suggest them Medicine, Fish, Egg and Mutton or other nutrition Meal .

Present Status – Babita Kumari now well and under treatment of Doctor and they follow of Doctor prescription or they free after 3-4 month from TV.

2. Case Study Community Development Committee Village- Bauaha Ward No.- 7, Panchayat- Mohanpur

Previous Status

Living Standard- Their living standard not good and other community do not touch them because they ware dirty cloth, leave in dirty as well as their home also dirty which is also effect in health. Educational Status- Educational Status is poor because their parents not send at school, Anganwadi for education. Only Sri Dinesh Sada s/o Rambahadur Sada and Budhani Devi is complete 10th standerd. Assessed of govt. scheme- One kattha land parcha distributed in 8 persons before 50 years now till date 24 family are surviving on that land. Indiraawas distributed by mukhiya ji in 1995-96 and also constructed by them but the construction materials like 16 bag sand and 1 bag cement mixture which is very poor mixture so after some time directly destroy automatically in the night and winter season at 9 Pm. Khushilal Sada and Rambahadur Sada were help through admitted in hospital them or all family with the help of villagers. We support them through collect some money and we also supported by Vidhayak for money support for 20 years and one hand pump.

Present Status- When interferes or supported by PGVS then Villagers attentively keep on cleanliness because of motivated or given training by PGVS or Animator and also formation of Village Development Committee, Mother Committee and Adolescent Committee for pass the information in committee. The PGVS gave training of this committee on Malnutrition, Education, Health and PRI work time to time continuously since one year and we follow them. Now the community are developing with the help of project related meeting and training. PRI members also support and short out of villagers issues and give information regarding Village development and we also participant in Gram Sabha. Anganwadi centrewe consult to ANM and assessed of women related scheme like enrollment in Anganwadi-Babita Devi, Lali Devi, Bechan Sada PDS assessed- Dhatri Mother- Madni Devi, Jordhari Sada, Rinku Devi, Lakhindra Sada, enrollment in School- Chhoti Kumari, Aman Kumar, Rupesh Kumar, Rupam Kumari, Old Age Pension- application applied of Rambadur Sada s/o Rajo Sada which is under process.

3. Case study of Mother Committee

Village- Chainpur, Panchayat- Chainpur, Block- Kahra, Dist.- Saharsa

Total 29 family house hold population of this village, Land location- North side padi, south side Balhi, East side Kahra and west side Gheghra situated. Before 2015 saw that each hose holder suffering from domestic violence, their children also live in dirty or careless and their nutrition or living standard are very poor. There had ownership status in upper cast and also not support to social activist, they believed in blind faith. 22 persons assessed land parcha in 2017 but they should not ownership. The PGVS implement or after supported by suposhan project and attend meeting training, they should developed yourself. They aware and fight for their right, now they done land mapping and made mud house and living there which is successes story. The children also live in clean way or developed through community from previous bad habit. Now they went to any work at Block and PRI for support, they also participant in Gram Sabha for Village development. Women also participant in Gram Sabha with huge population

Major learning's

The all project has a Rights Based Approach and focuses on enhancing the understanding of all project staffs, volunteers and leaders of DAM for inclusion of Dalits in Social, Economic Spheres of Society. Besides, the project is taking efforts to create an organized structure of DAM from village to state level by formation of Committees of DAM at villages, Panchayats, Blocks, Districts and State levels.

Challenges

The project is being implemented in a state where the overall governance is very poor. Lack of political willingness and de-politicization of issues have further made the situation challenging.
